Schedule and direct a crew of maintenance workers in the absence of the Maintenance Director involved in one or more craft specialties; train and provide work direction and guidance while performing work in one or more of the skilled trades. Perform skilled mechanical maintenance duties in the inspection, repair, installation and alteration of District heating, ventilation, air conditioning and refrigeration systems and related equipment and facilities; perform preventive maintenance and routine servicing of equipment. The successful applicant will be responsible for basic record keeping, heavy physical labor, to utilize proper lifting techniques, communicate effectively with others orally and in writing, work independently without direction and must have a minimum of two licenses in HVAC (master license preferred), boiler, wastewater, drinking water, electrical and warranty and repair certification for food service equipment.
